Any additional language product(s) or versions(s) included within the OPK may not be used.

You may not order associated Product end user deliverables (e.g., Digital Product Key, Certificate of Authenticity, media, documentation, etc) from a Microsoft Authorized Replicator or distribute the Product to End Users before you have executed a License for the Product.
